Certification of EuroVelo 1 – Atlantic Coast Route in France (also called *La Vélodyssée*)

Background

The French part of EuroVelo 1 – Atlantic Coast Route was surveyed and analysed with the <u>European Certification Standard (ECS)</u> methodology in 2019, in the frame of the AtlanticOnBike project, co-funded by the Interreg Atlantic Area programme. The survey was performed by EuroVelo Route Inspectors Corentin Lemaître (C-Mobilité) and Adrien Caillot. The last daily section of the route, from Saint-Jean-de-Luz to Hendaye, was surveyed again in 2023 by EuroVelo Route Inspector Aurélie Périgaud, following a major change of itinerary.

The analysis of the data collected in 2019 indicated that several critical issues were preventing the route to be eligible for EuroVelo Certification at that time. From 2021 to 2024, the collective of "La Vélodyssée" chose, as a priority activity, to "assist territories in resolving non-conformities identified in the ECS quality diagnosis and initiate the submission of justifications for a future EuroVelo Certification application". During this period, the partners along EuroVelo 1 in France gradually resolved the critical issues that had been identified through the survey and collected evidence of the improvements via pictures or other means.

The collective of "La Vélodyssée" submitted a final EuroVelo Certification application in July 2024, consolidating the work done over these 5 years and giving an overview of the current parameters and quality standards achieved by EuroVelo 1 – Atlantic Coast Route in France. ECF then undertook a detailed analysis of the route parameters and justifications received, to assess if EuroVelo 1 in France now meets the required ECS quality criteria to become a Certified EuroVelo Route (i.e. ECS essential criteria met on 100% of the route and ECS important criteria met on at least 70% of the route).

Let us note that this Certification process is different from what ECF generally advises, as the survey results used for most of the route are from 5 years ago. However, ECF agreed to follow a different process due to the strong governance system established by "La Vélodyssée", which allowed to perform quality checks and to gather proofs of solving the main issues that had prevented to reach EuroVelo Certification back in 2019.

Results

EuroVelo 1 – Atlantic Coast Route in France, from Roscoff to Hendaye, is Certified as a high-quality route within EuroVelo, the European cycle route network, until October 2029.


The EuroVelo Team congratulates the collective of *La Vélodyssée* for the impressive work done since 2020 to build a strong governance with an effective partnership along the route and collect evidence on the resolution of critical issues.

The full Certified route is 1,291 km long and comprises 38 daily sections. Overall, according to the justifications received on improvements made to the route's infrastructure and services, as well as commitment letters from the departments along the route to solve the remaining issues within a short timeframe, 87% of the route length meets essential and important criteria and 13% of the route length meets essential



criteria only. Sections meeting essential and important criteria in their entirety can be recommended for occasional and regular cyclists. Others can be recommended for regular cyclists.

The resolution of issues related to meeting additional criteria were not reported, as this is not required for EuroVelo Certification. However, based on the 2019 survey results, 3 daily sections, corresponding to 8% of the route length, were already meeting additional criteria and can thus be recommended to all kinds of users.



Overview of quality levels along the Certified EuroVelo 1 – Atlantic Coast Route in France

The EuroVelo Certification label is valid for 5 years, from September 2024 to September 2029. In order to renew the route's Certification after this period, the collective of *La Vélodyssée* should send a new EuroVelo Certification application to ECF by June 2029, based on the results of a new ECS survey.

Communication

On <u>www.EuroVelo.com</u> and other communication tools, the following changes will be implemented to communicate about the route's Certification:

- EuroVelo 1 in France will appear in green (*Certified*) on the interactive maps of the relevant stage pages (<u>here</u> and <u>here</u>) and <u>country page</u>.
- EuroVelo 1 in France will also appear in green in the next version of the EuroVelo printed map.
- The EuroVelo Certification label will be added to the page of EuroVelo 1 in France.
- The EuroVelo Certification label will be added to relevant bookable offers in the <u>bookable offers search</u> engine.

The certification status of each daily section and the user groups for which the section is recommended are laid out in the table below. The collective of "La Vélodyssée" and its partners are encouraged to communicate about the EuroVelo Certification of the route to the relevant target group(s) for each section and use the Certification logo in their communication materials accordingly.

Remarks and attention points

ECF has listed the following points of attention for the collective of *La Vélodyssée* to follow-up on with its partners, in order to ensure a continued high quality for EuroVelo 1 in France until 2029 and to allow for the route to be recertified after 5 years.

- Ground signage missing a mention of "EuroVelo 1" or "La Vélodyssée", in Saint-Brévin-les-Pins and around Les Sables d'Olonnes, should be completed by an identification of the route or route information panels.
- Clarifications on the planned works and implementation timetable should be obtained from the communes' community of Sud-Vendée-Littoral, given that their commitment email for improving cycling infrastructure on Av. Amiral Courbet and Route de la Tranche was lacking precise timings.
- By end September 2024, the resolution of the most important EuroVelo 1 signage issues along the Canal de Nantes à Brest and in Saint-Brévin-les-Pins should be verified, in accordance with the Loire-Atlantique Department's commitment from their letter dated 2 July 2024.
- By June 2025, *improvements made to EuroVelo 1 signage* in Brittany should be verified, in accordance with the Brittany Region's commitment from their letter dated 21 June 2024.
- By June 2025, *improvements made to EuroVelo 1 signage* in Vendée should be verified, in accordance with the Vendée Department's commitment from their letter dated 27 June 2024.
- By the end of fall 2024, the *construction of a new cycle and pedestrian path* in Rochefort to resolve a very high traffic section should be verified, in accordance with the works planned by the Charente Maritime Directorate for Environment and Mobility.
- A solution to improve the safety of the Pont de Seudre should continue to be looked for, in order to
 have a safe route outside of the boat operating times. In particular, test solutions to widen the existing
 cycling lane should be followed up on. Indeed, the current working time of the ferry allowing to avoid
 this dangerous is from June to September, which is acceptable but a bit short considering the extent
 of the cycling season.
- Between Royan and Hourtin Plage, EuroVelo 1 stickers should be replaced by full EuroVelo Route
 Information panels as soon as possible. In the meantime, maintenance works should be organised to
 avoid the stickers deteriorating.
- Clarification on the planned works and implementation timetable should be obtained from the Gironde Department, given that their commitment email for *harmonising EuroVelo 1 signing* was lacking precise timings.
- Clarification on the planned works and implementation timetable should be obtained from the
 Pyrénées Atlantique Department, given that their commitment letter for improving the safety of the
 route was lacking precise timings. In particular, the Department should realise additional counting of
 the levels of motorised traffic along the route and act depending on the results.
- In Nantes (along Route de Pornic), in La Rochelle and before Lacanau, where itinerary changes were introduced to improve the cycling conditions of the route, verifications should be made to check that no other quality parameters were altered by these modifications.
